Introduction

The purpose of this book is to settle the matter of the origin of man, his struggle between eternal life and death, and an explanation as to why these Realities are something that people mentally cannot accept.

It takes a lot to change a person's model of the world. Our reality is shaped during the first seven years of our life. Whatever our parents believe and those that they allow us to be exposed to believe determines our inner version of the reality of our world.

The most basic force driving our motives and actions, and our own personal system of belief stem from two things.

Firstly, we have a limbic system in our brain designed to keep us alive. It automatically keeps our heart beating and our lungs breathing. Inside our brain the limbic system also sends signals of fear in order to keep us away from sources of death to our self. We are driven from within to eat and to procreate.

Secondly, we have a system of religious beliefs or spirituality when we are reared in civilization. Before the year 1900 it was generally believed that the Bible was the most ancient book in civilization. During the century that followed came the unearthing of ruins of ancient civilizations. These digs into artifacts from ancient times provided ancient writings older than the Bible. When properly translated the Hebrew Bible and other more ancient writings say the same things.

A struggle with the translation of Hebrew words into English is the greatest barrier to reality. A long and difficult path of

trouble and searching for answers in books will uncover the lost reality of mankind, and his struggle between eternal life and eternal death.

We can also discover the reason why reality is not accepted by the human mind.

The Search for Truth.

By suffering you are called.

Many people go through life in a certain level of comfort, accept what they are taught, and die in their hope.

Some people encounter extreme suffering, react in violence or war, and die for their belief.

Some people encounter some amount of suffering, and no longer accept what they were taught, and eventually die.

A few people encounter suffering, and reject prior beliefs, so that they then seek a new reality that explains what they encounter.

Messiah shall swallow up death in victory!
(1st Corinthians 15:54, Isa. 25:8).

The Origin of Mankind and the origin of Religion unfold together.

Men desiring to prove or disprove the Biblical narrative, began to dig and study ancient artifacts. But it would be helpful to know the age of an artifact.

Modern Technologies

Carbon-14, also called radiocarbon, occurs in trace amounts in plants and animals. When they die the radiocarbon begins a slow decay. It takes about 5,400 years \pm 0.526% for the radiocarbon to decrease by half, which is 50%. This is called the half-life. Measuring the remaining radiocarbon in organic matter can be used to determine the age of death.

Radiocarbon was discovered in 1940, and its use in dating was started in 1949. Radiocarbon dating is a great benefit to archaeology. Scientists believe this dating method is reasonably accurate for up to about 50,000 years. A 0.526% variance over 50,000 years is 263 years. This same variance at 4,000 years is only 21 years. This should give us a sense of the excitement archaeologists felt when they started using this dating method.

In the 1970s DNA sequencing began, and ultimately the entire genome of humans, plants, and animals could be completed. The study of humanity, anthropology, is enhanced by the ability to compare genomes from the remains of individuals. However, the DNA does eventually break down over a very long time. Archaeology can deduce cultures and typical actions of humans by examination of artifacts in digs, but with radiocarbon dating and by comparing the genome between different individuals they can determine even more.

Discoveries and Ideas

Scientists believe that australopithecines, an ancient group of humans in Africa developed into modern humans, homo sapiens. Are there any ancient writings related to this belief? Ancient writings are important for understanding our past.

In modern Iraq there is a region in ancient times called Mesopotamia. The ancient kingdom of Sumer was there, and artifacts were uncovered there. The ancient writings of Sumer refer to their lords, i.e. rulers. Empire might be a better description of Sumer. Scientists have differing ideas of the origin of ancient Sumer. Tablets in Sumer were written in cuneiform, using symbols to represent syllables of their words, inscribed on primarily clay, but also on wood, stone, and metal. The most widespread writing was done with a reed onto clay, which lasts much longer than our modern paper. One archaeological site not very far from Nippur yielded over ten thousand clay tablets. Sumerian cuneiform is unique among cuneiform writings with much complexity, so experts had difficulty translating it into our modern languages. The Sumerians also had a habit of dating their writings. Today it is also common practice to date letters and accounting records. During the beginning of work to translate Sumerian cuneiform it was believed that Sumerian was a variant of Akkadian, but later they discovered their mistake. So was what a translator believed was a celestial boat actually a space-craft, and a Life Tree simply DNA?

When various civilizations wrote in their own language the names adapted from other writings were changed to those names

used in their own language. Was this to retain the meaning of the name? Whatever the reason scholars admit it was done.

One older translation of an ancient Sumerian clay tablet shows, that after a rebellion of workers replacement workers were needed. Then an ancient god-king discovered a being that walked erect on two legs. Was this *Homo erectus*? Modern scientists' writings indicate they were the first members of the genus *Homo*. And other hominids appeared after them, and finally modern humans. So if we change the older translation from fashioning essence is like two serpents entwined, to their DNA is like our Nucleic acid double helix, then is that the meaning in the Sumerian rather than the Akkadian? And if we change from when we combine our life essence with theirs, and a primitive worker shall be created, to if we combine our DNA with their DNA we can genetically engineer an intelligent species to work for us, then is that what they did in ancient times? In summary the tablet shows that after many failures the perfect-model Adamu is attained. Remember radiocarbon dating does not tell the time of creation or birth, but provides an estimated time of death. The Ancient Sumerian tablets also show these god-kings lived a very long time. Does that explain the development or evolution into modern humans? Notice the following citation.

Several human species, such as *Homo heidelbergensis* and *Homo antecessor*, appear to have evolved from *Homo erectus*, and Neanderthals, Denisovans, and modern humans are in turn generally considered to have evolved from *Homo heidelbergensis*, (citing Dembo M, Radovčić D, Garvin HM, Laird MF, Schroeder L, Scott JE, et al. Therefore if we change our lifestyle and diet in a specific way do we also have a capability for a very long lifetime? Do we do things that make us age faster than we should? Do we eat foods that cause disease and premature death?

Biblical Evidence

It is written in Genesis 1:27 in the King James Bible, So God created man in his *own* image, in the image of God created he him; male and female created he them.

The word God is rendered from the Hebrew word *elohim*, and is a plural form of a Hebrew word which means a deity, translated god. And the Hebrew word *elohim* means deities, translated gods. With this correction the simple direct translation of Genesis 1:27 is So *the* gods created man in his *own* image, in the image of *the* gods created he him; male and female created he them.

This indicates that these mighty gods were advanced beyond our knowledge and genetically engineer Homo sapiens very likely starting with Homo erectus.

Also, in this verse the word image is rendered from the Hebrew word *tselem* derived from another Hebrew word meaning to shade; and *tselem* means figuratively resemblance.

Therefore mankind has a similarity to the gods, and especially in mutual appearance.

But there is one more thing shown in the ancient Sumerian tablets. One of the gods added two essence branches to our Life Tree, but a greater god found out and expelled mankind from their central command post, and humans went back to the place they were first discovered. Apparently humanity is too close to the gods for the gods comfort.

Acceptance or Rejection

Now most people will reject much of these things because it does not match the version of reality within their subconscious mind. One man believes he was created by one powerful God, another believes he was created by Allah, and another might say he was created by Yahweh. Some say Yahweh, which is Hebrew, was originally Enlil, who according to the Sumerian tablets came to earth (a.k.a. Ki) to direct the critical operations needed for their own planet. And it was well known that names were changed between different languages. Also, there is now ample evidence that some of the Old Testament writings were adapted from more ancient writings, shared with Babylon and more ancient Sumer.

Our subconscious Formation

During the first seven years of our life we form a model of reality deep within our minds. These beliefs learned from our parents, teachers, and preachers, are anchored in our minds. From these foundational beliefs bias takes place, which controls our future ability to judge new information. Information that conforms to the anchored beliefs can be accepted by the mind from a source believed to be trustworthy, but information that does not confirm to the anchored beliefs is automatically rejected by the subconscious mind. It is not even considered a possibility.

Fidelity

By suffering we are called. Few there will be that find the truth. Now shown by the original Hebrew in Habakkuk chapter 2 verse 4 in the final phrase of the verse:

The just shall live by his *steadfast* **fidelity**.

The *Strong's Concordance of the Bible* lists the Hebrew word translated fidelity as number 530. This is the Hebrew word *'emwnah*. Strong's Hebrew Dictionary shows this word means figuratively fidelity, and literally firmness.

Fidelity means exact correspondence with fact (see page 313 in the *American Heritage Dictionary 3ed.*).

Whatever your system of faith might be, and whatever name the being that created your ancestors had, should we not take care that what we believe matches reality?

As is was written in Isayah/Isaiah 53:1 and cited in Romans 10:16—

Not everyone conforms to the gospel. Who has supported our announcement?

The Lost Faith

Let us conform to reality as it unfolds before our Eyes?

Let us restore the gospel and conform to fidelity?

Messiah shall swallow up death in victory! (1st Corinthians 15:54, Isa. 25:8).

Is eternal life lost? Is the Gospel Hidden from us?

Second Corinthians 4:3–

But if our gospel is hidden, it is hid to them who perish.

The word perish is traditionally translated lost, but Strong's Concordance and Greek Dictionary shows that this word is translated from Greek word number 622 and means perish. This is the same as Hebrew word number 8 derived from 6.

Numbers 24:20–

Then he looked on Amalek, and uttered his oracle; Amalek was the first among the nations, but his end shall be to perish forever.

Expounding this Hebrew word we find the people shall wander away, i.e. lose them-selves, and be caused to destroy and to perish. Moreover, this is permanent.

Notice the last part of James 1:22 in the Bible.

But be ... not hearers only, deceiving your own selves.

Deceiving is translated from Greek word 3884 *paralogizomai* meaning to misreckon, i.e. delude.

Notice a careful translation of the Greek to English for Second Corinthians 3:15—

And even now on this day when Moses is known again: a cover will lie outstretched on the heart itself.

It was not until 325 C.E. that the Old Testament became part of Christian Doctrine under the direction of a Roman Emperor and the group of religious leaders he had assembled.

The problem with these changes is that iniquity causes people to sin without knowing it, but when the curse, a.k.a. crime caused by the sin takes place, then tough Roman justice is enforced.

The lost gospel prevented the sin because iniquity was purged from the gospel and true virtue was restored.

Notice what is written Yahchanan, a.k.a. John 16:1—

These things I have uttered unto you, so that you would not be entrapped; *i.e. be caused to sin ignorantly and a curse fall upon you.*

But as shown in the old *Foxe's Book of Martyrs* the disciples were dispatched and the original pure gospel message was destroyed.

Notice Luke 5:39—

No man also having drunk old *wine* straightway desireth new: for he says, The old is better.

It is said wine is figurative for teaching, so here is the explanation. Once you have practiced the Old Testament, you will not easily accept the New Testament: for the mind will believe that the Old Testament is better than the New Testament. Is not the oldest the original and therefore the most accurate? It should be, except it was changed by men, who died long ago.

Notice what is written in Yechetzqyah, a.k.a. Ezekiel 5:5-6—

5 Thus says the Lord GOD (Supreme in Authority, Yahweh); This is Jerusalem: I have set it in the midst of the nations and countries *that are round about her.*

6 And she has changed my judgments into wickedness more than the nations, and my statutes more than the countries that are round about her: for they have refused my judgments and my statutes, they have not walked in them.

Moreover it is written in Yeremyah, a.k.a. Jeremiah 14:14—

Then Yahweh (the LORD) said unto me, The prophets prophesy lies in my name: I sent them not, neither have I commanded them, neither spoke unto them: they prophesy unto you a false vision and divination, and a thing of nought, and the deceit of their heart.

The phrase thing of nought is translated from the Hebrew *'eliyl* and means good for nothing, but specifically an idol (i.e. the writings of men's hands). This is talking about idolatry and the iniquities cleverly concealed within it.

Notice the prediction written for our time in Revelation 9:21—

Neither did they *feel guilty to reconsider* their murders, nor their witchcraft, nor their harlotry, nor their stealing.

These murders are also explained by the Messiah.

Yahchanan, a.k.a. John 16:2—

They will excommunicate you. Yes, the time comes, that whoever kills you will believe that he serves Yahweh by fulfilling a community duty.

The deception is very strong, and people wanting to solve problems will believe executions are the right thing to do.

Notice the following news article.

It is ironic that these people are actually victims of a broken world-wide system of **law and order, or the rule of law**. The people that believe and follow these things are all likewise victims of an ancient deception perpetuated by men who died long ago.

Notice what is written in Second Thessalonians 2:10-11—

10 And with the whole delusion of wrongfulness in those who are perishing, because they did not receive the love of the genuine faith unconcealed, that they might be saved.

11 And for this reason, Yahweh will send them powerful fraudulence, that they would believe a falsehood,

How do we today fail to receive the love of the genuine faith? Because the ancient Roman Empire burnt it up!

This is shown in the old *Foxe's Book of Martyrs*. This book in its oldest edition was once a popular book to have alongside a Bible. Today would a student be expelled for bringing both of these to school to read to classmates during a recess?

It appears that the entire world is in a deadlock, and headed for total self destruction.

The ancient Sumerian tablets chronicle the destruction of ancient Sumer by a limited nuclear exchange, but unable to control the wind, the fallout killed these people off. Before it took place Abraham was instructed to leave Mesopotamia. He was chosen because his was able to read and write and had writing on hand, for he was a prince among the people. Notice the King James.

Geneses 32:28—

And he said, Thy name shall be called no more Jacob, but Israel: for as a prince hast thou power with God, Elohim i.e. the gods and with men, and hast prevailed.

John 8:39b—

If ye were Abraham's children, ye would do the works of Abraham.

The word do above in verse 39 is translated from the Greek word (no. 4160 in *Strong's*) *poieo* and means to make or do.

The children of Abraham made copies of the works of Abraham. But, the writings were corrupted.

Malakyah, a.k.a. Malachi, 2:1,6,8-9—

1 And now, O you priests, this commandment *is* for you.

8 But you have turned off the way; you have caused many to stumble at the law; you have corrupted the covenant of Levi, says Yahweh of hosts.

9 Therefore have I also made you contemptible and base before all the people, according as ye have not kept my ways, but have been partial in the law.

The law was passed down is in parts, and out of order.

The apostle Shaul, a.k.a. Paul wrote a letter to Titus.

Notice was is in Titus 1:4-5—

4 To Titus, *mine* own son after **the common faith**: ...

5 For this cause left I you in Crete, that thou shouldst set in order the things that are lacking *virtue*, and ordain elders in every city, as I had appointed you :

There is a way to take the law passed down in parts, to set in order the things that are lacking, so that the law will then contain the missing virtue while purging out iniquities.
